There were no recommendations as a result of the review – as such the report is informational only. Work continues on the transition audit of the Sheriff's Office. Baker Tilly has completed most
of their field work on the agreed upon procedures. However, certain components cannot be
completed until after the fiscal year end has been closed and the supporting subsidiary reports
are generated. The Kane County Auditor's office is performing the majority of the audit work in
the overall scope of the transition audit.

Sheriff Kramer and his staff have been involved in the planning of the agreed upon procedures that collectively make up the transition audit. Their ongoing cooperation will be appreciated, and necessary to complete the remaining field work and issue the required report within the mandated requirement deadline.

 Typically the Auditor's Quarterly Report for the fourth quarter of fiscal 2014 would have been issued by now. The report has been delayed pending the resolution of certain budget amendments which have yet to be considered by the Board. It is anticipated that at next month's Finance and Budget Committee meeting both the fourth quarter report for fiscal 2014 and the first quarter report for fiscal 2015 will be available and presented at that time.

Accounts Payable Claims Paid Report

1,653 invoices were processed in January 2015 which resulted in payments of \$7,074,160.
